- 4. The tenders regularly submitted are deemed to be firm until the lots are sold by auction; they cannot be revised or withdrawn before they are given to the Chairman of the Sales Committee.
- 5. The price, is a fixed price
- 6. The term of the payment contract is: Bank transfer (Swift), cash:
 - on presentation of Export Documents validated by ODECA and Burundi Central Bank;
- 7. Period of payment: Payment must be done before shipment.
